All dogs must at the time of entry for the competition, be REGISTERED as required by the Kennel Club Limited Rules and Regulations in the owner's name (or else registration or transfer of registration applied for). If the registration or transfer of ownership has not been confirmed it must be applied for before the closing date of entries. In case of dispute proof of postage of such applications may be required by the Kennel Club. Dogs under 18 months of age on the day of competition cannot be entered for competition. On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and USE BLOCK CAPITALS throughout when completing this entry form. Not for competition entries will be accepted for dogs aged 4 calendar months and over. The Kennel Club Authority to Compete (ATC Number) for dogs resident outside of the UK must be stated or the entry will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.
